Guidelines for Residents

Issued on May, 6th 2020

QUERY	CLARIFICATION
1. Industrial Permissions	<ul style="list-style-type: none"> • As per New GO no.1003, dated 5th May, 2020 In Non containment areas of Red zone district/GBN, "After getting self-declaration from Industrial units, Authorities/GMDIC shall put up permitted list (as per MHA) Industries which are allowed to operate, for which orders to operate shall be immediately issued". • Those industries who have got permitted through portal / email need not apply again and can start operation immediately. • It is clarified that as per the government order "Mobile Phones and accessories" are covered under "manufacturing and IT hardware". • Whether or not ITES is covered under "Manufacturing of IT hardware" or "Private offices" has been referred to the Government • The government is committed to ensure all permitted industrial activities can start with seamless interface and transparency.
2. Do the workers/ Employee working in Industrial units needs any separate passes.	<ul style="list-style-type: none"> • No. • ID card issued by the Industrial Unites shall suffice. • In case of industry employing 50 or more workers, they have to have dedicated vehicles, the registration no's to be intimated to DCP Traffic
3. Regarding private offices	<ul style="list-style-type: none"> • As per MHA Guidelines private offices shall work with 33% of their total work force. • They do not need any separate pass they can go to office with their valid ID card issued by Respected Offices.
4. Government offices	<ul style="list-style-type: none"> • As per MHA Guidelines • They do not need any separate pass they can go to office with their valid ID card issued by their respective/ Competent Authority.
5. Closure of Interstate and Inter district borders	<ul style="list-style-type: none"> • Closure of Interstate and Inter district borders shall remain in force. No relaxation has been made in this regard. • There are no passes being issued for inter district and interstate travel of personnel even for permitted commercial and Industrial activities.
6. Inside containment zones	<ul style="list-style-type: none"> • Inside containment zones, only Essential/emergency goods, services are allowed. All other Permitted activities applicable for Non containment zone only.

7. Guidelines with respect to essential services	<ul style="list-style-type: none"> • Apart from emergency services, following essential services are permitted- Electrician, Plumber, Repair/Maintenance of Fan, RO water purifier, AC, Fridge, Washing Machines, Internet/broadband They do not require any pass.
8. Entry of Maids	<ul style="list-style-type: none"> • We do understand that, It involves rights of maids/ house help, Individual residents and RWA's. Considering the diverse views received, we have decided that, A. The consent of the maid/ house help is must B. Maid/ house help can come only from Non-containment zone. C. One maid/ house help can work only in one house. In all cases where A, B, C, condition are met. 1). If RWA's agree and form a consensus in allowing maids administration shall have no objection. 2). If RWA's do not form a consensus, Then entry of maid is Not permitted.
9. Guidelines on perimeter control	<ul style="list-style-type: none"> • Strict measures to ensure controlled movement of population in and Out. • Residents are allowed to commute for permitted activities.
10. Guidelines on Residents to take walks Outdoors.	<ul style="list-style-type: none"> • Not Permitted
11. Advisory on pets	<ul style="list-style-type: none"> • Pets to be taken out for walks not for more than 15 minutes. Residents to ensure sanitary measures be exercised during the time.
12. Mobility of residents	<ul style="list-style-type: none"> • Allowed for permitted Activities only.
13. Guidelines on use of elevators	<ul style="list-style-type: none"> • RWAs can regulate based on social distancing and capacity of the lift.
14. Guidelines on access of staff (Car cleaners, Dhobies/Drivers etc.)	<ul style="list-style-type: none"> • Policy Same as Point- 8
15. Guidelines on use of common facilities	<ul style="list-style-type: none"> • Not Permitted except in emergencies.
16. Guidelines on delivery of utilities	<ul style="list-style-type: none"> • RWAs shall develop internal system for door step delivery mechanism for milk packets, newspapers, groceries, etc. They can identify points based on space available in the society. • RWAs must ensure the sanitization of such places.
17. Guidelines on visitor entries	<ul style="list-style-type: none"> • Not permitted except in emergency services. Residents are advised to not invite guests during the lockdown period.

18. E-Commerce guidelines	<ul style="list-style-type: none"> Allowed only for essential services.
19. Construction/Fit-Out Labour	<ul style="list-style-type: none"> Only In-Situ activities permitted.
20. General guidelines on standards of hygiene	<ul style="list-style-type: none"> Persons above the age of 65 years of age, with co- morbidities, pregnant women, and children below the age of 10 to not venture outside the premises of one's own home unless for medical emergencies and severe critical essential requirements. Guidelines provided from time to time by Ministry of Health and Family Welfare, GoI, UP Govt. & Distt. Administration to be followed. Spitting in public places/any area shall be punishable with a fine. Consumption of liquor, paan, gutka, tobacco in public places and common areas are not allowed. Residents to wash hands regularly with soaps/sanitizers and to wear a mask. Wearing mask is essential for visiting public places.
21. Guidelines on health(COVID- 19 symptoms)	<ul style="list-style-type: none"> Regular monitoring to be done by residents of their health status. If any COVID-19 symptoms such as fever, cough, sore throat, shortness of breath, etc. are detected, immediately must intimated to the District Surveillance Officer/ Gautambudhnagar integrated control Room number- 1800-419-2211
22. Vehicles Restrictions	<ul style="list-style-type: none"> Only 1 rider on a two wheeler and 2 passengers along with driver permitted in 4 wheeler
